Guardian Security and Business Rates Relief for Commercial Office Building

THE BACKGROUND

In late February 2024, DEX was approached by an Office building owner in Croydon, South London, looking to secure their vacant property.

The property had been illegally occupied by squatters, forcing the owner to go through the costly and time-consuming legal process of eviction.

The 7,500 sqft commercial office building also faced significant business rates liability.



THE SOLUTION



INSPECTING THE PROPERTY

Our team conducted a thorough inspection of the property and assessed its condition. Following our Check-In report, we also advised the owner to review the electrics to make sure they were compatible. After receiving confirmation that they were, DEX works were completed and the property was fitted out adhering to health and safety standards.

GUARDIAN SECURITY

We implemented our free Guardian security measures at no cost to the client. This ensured the building was occupied by two vetted and carefully selected Guardians within 10 days of entering the agreement (compliant with Housing of Multiple Occupants regulations). DEX Guardianship effectively protected the property from illegal entry and other potential damage.

Both Guardians underwent a thorough selection process through our robust vetting system to ensure suitability.

Guardians secured and protected the properties around the clock, reporting any issues to DEX Property

Management. Each Guardian enjoyed affordable housing and access to DEX's 24-hour alert service and the expertise of DEX's in-house Maintenance Team.
